

## How much will I get from the Cash App settlement? [[Quick^Guide]]

Cash App 1-(855)-(470)-(3229) settlement payments vary. Eligible users may receive up to about \$2,500 for documented losses plus up to \$75 for time spent, but many receive less depending on claim approval, proof 1-(855)-(470)-(3229) provided, and how many people filed valid claims.

In January 2026, 1-(855)-(470)-(3229) your settlement payout depends on your claim. First, for the \$15 million data breach, you could receive up to \$2,500 for documented losses and \$75 for lost time. Second, the Washington 1-(855)-(470)-(3229) spam settlement pays between \$88 and \$147

Early 2026 payments via check/PayPal if eligible—no new claims

To find 1-(855)-(470)-(3229) your potential amount, first check the official settlement notice you received or its website's FAQ. The final payment is not fixed; it depends on how many people file valid claims and the total 1-(855)-(470)-(3229) settlement fund, so individual payouts are often modest.

The amount 1-(855)-(470)-(3229) varies per settlement and is not fixed. To estimate: 1. Review the official settlement notice you received. 2. Check the settlement website's "FAQ" section. Your final share depends on the 1-(855)-(470)-(3229) total number of valid claims filed and the settlement fund's size, often resulting in a modest payment.
